Faculty members pursuing tenure and career success in research intensive institutions, postdoctoral fellows and visiting assistant professors transitioning to or seeking tenure track appointments, academics transitioning from teaching to research institutions, and faculty carrying out research in teaching contexts will be interested in this Summer Research Institute (SRI). This institute is designed to promote successful research projects and careers among faculty from underrepresented groups working in areas of crime and criminal justice. *During the institute, each participant will complete the project proposed in this application (either a research paper or grant proposal) in preparation for journal submission or agency funding review.* The institute will provide resources for completing the project, senior faculty mentorship, networking opportunities, professional development workshops, and a culminating symposium. Travel and living expenses will be covered by the institute.

The SRI is organized by Professor Emerita Ruth D. Peterson, the Criminal Justice Research Center (CJRC), and the Department of Sociology at Ohio State University. Funding is provided by the National Science Foundation and offices of Ohio State University.

Full applications must include:

1. Completed application form;
2. Statement of interest (double-spaced, 250-500 words);
3. An abstract that describes in brief (100-150 words) the project to be carried out during the institute;
4. A complete draft of a research paper/proposal with full references and tables (if relevant)-*please do not send a set of unedited chapters from your dissertation or a paper that is only partially complete*; and
5. Your Curriculum Vitae (CV).

Eligibility: Applicants must hold or be transitioning to regular tenure-track appointments in U.S. institutions, and demonstrate how their academic involvement broadens participation of underrepresented groups in crime and justice research.

Specific Instructions:

1. *Completed application form.* Fill in all personal information. The "Proposed Project Title" refers to the paper (or grant proposal) you plan to complete during the institute.
2. *Statement of interest (double-spaced, 250-500 words).* In this short essay please:
 - a) introduce and briefly describe your research project and its intended contribution;
 - b) explain how and why you would benefit from participation in the institute, and how your involvement would contribute to broadening participation of underrepresented groups in crime and justice research; and
 - c) explain what types of activities will facilitate achievement of your goals.
3. *Abstract.* Please describe in brief (100-150 words) the project to be carried out during the institute.
4. *Paper draft.* This paper may be a draft of a completed paper that needs additional work before sending out for publication review, a paper that was submitted for publication but failed in the review process, or an extended proposal for a research paper or grant application. This paper must be the project that the applicant intends to complete while at the Summer Research Institute.
5. *Curriculum Vitae.* Please include an updated version of your CV.
