FEATURED GRADUATE STUDENT

Lisa Cravens-Brown Ph.D. candidate in the Department of Psychology The Ohio State University

Lisa is a seventh year graduate student in the Department of Psychology at The Ohio State University. Her area of concentration is child clinical psychology. This is her last academic year at OSU and next year, she will be a child clinical intern at the University of North Carolina-Chapel Hill. There she will focus on pediatric, child forensic and community child psychology. Lisa also received her Bachelor's and Master's in Psychology from OSU.

Because Lisa's focus is on clinical psychology, she spends most of her time in the field working with clients. The population she most likes working with is juvenile sex offenders. She first became interested in this group while a practicum student at St. Vincent's Family Centers (Columbus, Ohio) under the supervision of Dr. Leslie Rudy, a licensed psychologist, who had written a dissertation on juvenile sex offenders. She continues to work with the St. Vincent Family Centers to evaluate, design, and implement juvenile sex offender programs. Based on these hands-on experiences, Lisa is very passionate about helping young offenders and hopes that she can learn to treat them.

Lisa's clinical experiences form the basis for her dissertation which investigates the mechanisms that contribute to juvenile sex offending. In particular, she will examine the relative impacts of temperament such as a cold callous interactional style, cognitive deficits such as impulsivity, and socialization factors like parenting in order to provide a fuller picture of the processes that lead juveniles to engage in sex offenses. Her sample will consist of approximately 80 male subjects between the ages of 13 and 18 years, of which 40 will be juvenile sex offenders and 40 will be non-offending adolescents. Juvenile sex offender subjects will be recruited from local community mental health centers and non-referred subjects will be obtained from local recreation centers and other community organizations.

Lisa feels that her dissertation work is important because she will be the first to explore whether

deficits in cognitive functioning characterize juvenile sex offenders as they do other antisocial adolescents. Her research is also the first to examine the construct of psychopathy in an outpatient sample of juvenile sex offenders. Lisa hopes that this study can outline for clinicians the most appropriate treatments for juvenile sex offenders. This dissertation is funded by the Criminal Justice Research Center and the Graduate Student Alumni Research Association.

Upon completion of her doctorate, Lisa's ideal job would include teaching, program evaluation research, and direct clinical practice. But just as important, Lisa wants to take part in efforts that link empirical research with clinical practice. She feels that only by integrating research with practice can we strive to make treatment programs really effective. To do so, she hopes to spend most of her time in a clinical setting like a guidance center or a hospital.

Lisa is fully committed to the area of juvenile justice and wishes to continue working with juvenile sex offenders. She wants to contribute to the field of criminal justice by better serving these young offenders. To do so, Lisa hopes to be take part in efforts that connect juvenile system officials with treatment providers. From her perspective, young people must deal with the consequences of their crimes but they must also receive treatment so that they can be rehabilitated. Lisa argues that the more effective treatments we design and implement, the more likely policy makers will support rehabilitative programs that treat juvenile offenders.

In addition to being busy with her academic responsibilities, Lisa enjoys spending time with her supportive husband Scott, and their two year old daughter, Alden.
